

Balance Sheet Explanation

Welcome to February's explanatory letter. Fixed Assets **Building** has seen an increase of L\$ 200 as a result of the purchase of 1 new building and **Equipment** increased in the amount of L\$ 11,991 from the purchase of a government mailbox system, the Magazine Factory Lite publishing system, T-Shirts for the new exhibit in MoCA, an Intan Couples Dance Ball and other assorted accessories purchased for the CDS 1st. Annual St. Valentine's Day Ball.

Current Year Earnings are a loss of L\$ 79,713 or US\$ 341.65 and Retained Earnings – Previous Year and Capital remain unchanged.

Comparative Income Statement Explanation

For the month of February the amount of tier collected was L\$ 258,964 or US\$ 1,040.02. Land Sales Revenue was L\$ 12,256 or US\$ 49.22 and Other Revenue was L\$ 200 or US\$ 0.80. So the Total Revenue for the CDS for the month of January was L\$ 271,420 or US\$ 1,040.02.

Linden Land Tier Expense dropped down to L\$ 267,675 or US\$ 1,075.00. The slight change was due to the exchange rate of US\$1/L\$249. Our **Currency Conversion Charges** was L\$ 9,457 or US\$ 37.98. Our **Events Expenses** for the month of February was L\$ 43,800 or US\$ 175.90 which consists of L\$ 25,000 for Mankind Tracer, L\$ 1,800 for Deejay Poppy, and L\$ 10,000 for the balance owed to Nadine Morani; all for the St. Valentine's Day Ball. L\$ 6,000 for AMFORTE Clarity and L\$ 1,000 for Arabelle Gravois for the Mardi Gras concert the CDS hosted in New Toulouse.

Our **Professional Fees** for the month of February was L\$ 18,500 or US\$ 74.30. This was L\$ 3,500 for normal stipends and L\$ 15,000 to Delia Lake for the set-up of the new exhibit in MoCA. Delia donated these proceeds to the not-for-profit group Virtual Ability.

Our **Web Hosting Expense** remained constant at L\$ 2,820 or US\$ 11.33. Our **Advertising/Marketing Expense** and our **Miscellaneous Expense** were a combined total of L\$ 541 or US\$ 2.13. So the total expenses for the CDS for the month of February was L\$ 342,793 or US\$ 1,376.68. The difference between **Total Revenue** and **Total Expense** is a net loss of L\$ 71,373 or US\$ 286.64.
