### **Balance Sheet Explanation**

Welcome to July's explanatory letter. **Current Term Earnings** are a loss of L\$ 31,731 or US\$ 127.43 **Retained Earnings – Previous Term** is L\$ 3,778,891 and Capital remains unchanged at L\$ 11,297.

# Comparative Income Statement Explanation

For the month of July the Land Tier Revenue was L\$ 254,285 or US\$ 1,061.39. Land Sales Revenue was L\$ 5,352 or US\$ 21.49. Total Other Revenue for the month of July was L\$ 289 or US\$ 1.16. The Total Revenue for the CDS for the month of July was L\$ 269,926 or US\$ 1084.04.

**Linden Land Tier Expense** remained constant at L\$ 267,675 or US\$ 1,075.00. Our **Currency Conversion Expense** was L\$ 9,624 or US\$ 38.65. Our **Events Expense** for the month of July was L\$ 2,060 or US\$ 8.27. The last Friday in July was the first time we held the 7Seas Fishing Contest. The contest is held each Friday at 9pm SLT and for this event we had two contests, 30 minutes each, with L\$ 750 in the pot for each contest. The other event expense is L\$500 for Wyvern Drake who hosts the contests for us.

Our **Web Hosting Expense** remained constant at L\$ 2,820 or US\$ 11.33. Our **Advertising/Marketing Expense** and our **Miscellaneous Expense** were a combined total of L\$ 835 or US\$ 3.35. So the **Total Expenses** for the CDS for the month of June was L\$ 283,014 or US\$ 1,136.60. The difference between **Total Revenue** and **Total Expense** is a loss of L\$ 13,088 or US\$ 52.56.
